As an Education ERP 4.0 solution, it leverages cutting-edge technology to offer a comprehensive and integrated platform that enhances the efficiency, productivity, and overall performance of schools, colleges, and universities.

Sreekrishnapuram V T Bhattathiripad College also transformed to the EMBASE Prosuit system in 2022 itself. In the beginning, the college used the package for Attendance Monitoring of the students. Later from the academic year 2023 onwards, the teachers used the EMBASE for the easy implementation of Outcome Based Education (OBE).

Now, the teachers are in a position to evaluate the attainment of Programme Outcomes (POs) and Course Outcomes (COs) through this software on a single click.

The EMBASE administrator of the college enters the Programme Outcomes in the sight. Then the HODs of each department enter the Programme Specific Outcomes in the EMBASE Portal. Then the class tutor enters the Course Outcomes in the portal and also maps each POs with COs.

Then the class tutor constructs an Outcome Based Internal Question Paper and enters it into the portal. After the tutor takes the class test in the class based on the Course Outcome and evaluates the answer sheets, the tutor enters the marks of each question in the portal.

Now the tutor can download the Report on Attainment of POs and COs with just a single click!!!






Step 3: Entering Course Outcomes in the Portal by the class tutor




