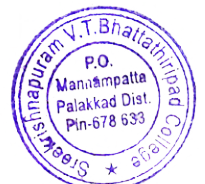

Basis of Audit Opinion

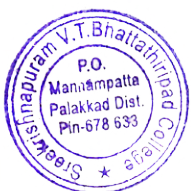
